DEPARTMENT UPDATES FOR COMMITTEE:

Brenda Wiemann (Office for the Aging) –

- CCOFA staff made over 1200 contacts with seniors for vaccine assistance in the first quarter of 2021, in addition to their regular work load. A new contract with Cayuga Community Health Network began 4/1/21 and they will be handling most of this effort through the end of the year.
- The Director met with Christopher Community representatives to evaluate space at Boyle Apts for COB OFA staff. Preliminary drawings are pending, but looks like this could accommodate all with HIPPA complaint space.
- During Volunteer Recognition Week, our Volunteer Coordinator displayed thank you posters on sandwich signs and shared a custom video thanking volunteers for all they do. The video was e-mailed to volunteers and is on our Facebook page and ARMA as part of our volunteer retention activities.

OFA HDC5 amend budgt

Authorization to accept additional funding from the NYS Office for Aging (NYSOFA) through the HDC5 program of the Consolidated Appropriations Act

WHEREAS, NYSOFA has received federal stimulus funds through the Consolidated Appropriations Act; and

WHEREAS, because New York State has received a Major Disaster Declaration (MDD) from the federal government, these grants can be used for any disaster relief services for older adults; and

WHEREAS, additional funding in the total amount of \$37,252 has been allocated from NYSOFA to Cayuga County through the Cayuga County Office for Aging under the HDC5 program of the Consolidated Appropriations Act; and

WHEREAS, the Office for the Aging 2021 budget needs to be amended to reflect the additional funding and services to be provided; now therefore be it

RESOLVED, that the Office for the Aging be authorized to accept additional funding from NYSOFA and the 2021 budget be modified as follows:

HD WIC Lease Agreement rev

Authorizing the Public Health Director and the Chairman of the Legislature to enter into a 5 year lease agreement with ABC Cayuga to house the WIC office/clinic

WHEREAS, the Health Department’s WIC Program (office and clinic) has been presented the opportunity to lease a space in the newly purchased ABC Cayuga building on North Street in Auburn, NY which will provide one-stop opportunities for early childhood services for members of the community; and

WHEREAS, the Health Department wishes to enter into a 5 year lease agreement with ABC Cayuga for use of this new space for the WIC Program; NOW, THEREFORE, BE IT

RESOLVED, the Public Health Director and the Chairman of the Cayuga County Legislature be authorized to enter into a new lease agreement with ABC Cayuga for space in their new building on North Street in Auburn beginning when the WIC Program begins to occupy the space on North Street until 5 years from that date, and renew this lease agreement annually upon such form as approved by the County Attorney’s office; and be it further

HS Huntington Contract 2021
