911:

- 9-22-JP-1 Authorizing the Chairperson of the Legislature to sign a one year contract with Eaton Corporation for maintenance of the Uninterruptible Power Supply (UPS) in the backup 911 center. **Motion by Daly, 2nd by Dennison, all in favor.**
- 9-22-JP-2 Authorizing the Chairman of the Cayuga County Legislature and the Cayuga County 911 Administrator to accept the 2021 Public Safety Answering Point (PSAP) Grant. **Motion by Petrus, 2nd by Daly, all in favor.**
- 9-22-JP-3 Authorizing the Chairman of the Cayuga County Legislature to sign an agreement with Yates County to share tower space at the Ovid Tower Site to improve radio coverage for Yates County. **PULLED**

• Lloyd Hoskins (Assigned Counsel) –

- There were **81** arraignments at the Centralized Arraignment Program for the month of August. The Assigned Counsel office calendared sixteen attorneys to cover the 7am and 7pm arraignments. The attorney cost associated with CAP for August was \$11,980.00. *These expenses were paid from an ILS (Indigent Legal Services) grant.* Of the 81 arraignments, **25** (31%) were for town/village courts, **56** (69%) for Auburn City Court. **47** (58%) defendants were released (ROR), and **34** (42%) defendants were held on bail or held for other reasons. Of the 81 arraignments, 40 (49%) were brought in on arrest/bench warrants. 26 Orders of Protection were issued.
- There were 77 Counsel at First Appearance for Auburn City Court and 15 Counsel at First Appearance in town/village courts. The Assigned Counsel office calendared fourteen attorneys to cover the "on-call" arraignments. The attorney cost associated with Counsel at First Appearance for August was \$8,800.00. These expenses were paid from an ILS (Indigent Legal Services) grant.
- The Assigned Counsel office made attorney assignments to **80** defendants in Auburn City Court and **19** defendants in justice courts for August. A total of **53** assignments were made in Family Court.
- The Assigned Counsel Office submitted a three grant under "Distribution 13" in the amount of \$131,049.00. If this grant is approved by the Office of Indigent Services, Cayuga County would be reimbursed for "complexed" criminal and family court cases.
- The Assigned Counsel Office has received three applications for the supervising attorney position. Interviews have been scheduled with a goal of filling the position by mid-October.

Staff Vacancies and Issues;

- Probation Officer vacancy; candidate scheduled to start Monday, Sept. 19th. Complement of officers now up to full strength.
- A Senior Typist remains out on medical leave. Return date is not known.
- One Probation Officer has had some challenging health news which could lead to a substantial amount of time out of the office. Follow up surgery is reportedly necessary.
- Both newly hired officers will be attending training in Erie Co. beginning in early October.

o COVID;

No recent issues. Department has returned to functioning near to pre-COVID operations.

Brian Schenck (Sheriff) –

- At the time of this report we are holding 159 incarcerated individuals in the jail. This includes 37 Federal board ins, 1 Local board in, 13 NY State Parolees detained for new charges and 3 Parolees detained for a violation of parole.
- We continue to partner with Cayuga County Mental Health and other community partners to establish a state mandated Medication Assisted Treatment (MAT) program within our jail. We are on target to start this program in the near future. We have begun moving incarcerated individuals that are struggling with substance abuse into one dedicated pod within the jail to help facilitate this initiative that will include increased peer support and programming.
- At the time of this report we have 8 current vacancies in the Custody Division (jail). There are also 2 vacant positions in the Road Patrol Division. We recently filled 1 position on our County Office Building Security Team after 3 recent resignations and we continue to recruit.
- We are currently partnering with Chairman Gould and multiple departments within the county to review current strategies, policies, and practices to address violent extremism in our community and prepare to draft a plan to confront domestic terrorism per State Executive Order 18 by the end of December.
