George P. Diehl, Jr., prominent local industrialist, civic leader, who served with distinction on county and city boards involved with planning and economic development and most notably assisted the late Mayor Paul W. Lattimore in recruiting Auburn Steel Company and the Miller Bottle Plants to the County of Cayuga.

Ruth Mitchell Webster, a former Cayuga County Legislator from the Town of Aurelius. Mrs. Webster was appointed in March of 1983 to fill the unexpired term of her late husband Ralph H. Webster on the legislature.

Mrs. Webster was a prominent civic leader and was well known for her home made apple pies and mustard ham glaze, which were enjoyed by local politicians over the years at the Fosterville Methodist Church spring and fall church dinners.

John R. Laidlaw, former Supervisor, Town of Aurelius and area civic leader.

Mr. Roger E. Bradley, Town of Genoa, retired prominent local banker, farmer and civic leader. Mr. Bradley was a former member of the Cayuga County Industrial Development Agency.

Mr. Frank J. McHale, Father of Susan M. Dwyer, Cayuga County Clerk.

W. Bernard Craine Jr., Prominent Local Farmer, Civic Leader and District One Cayuga County Legislator from 1976 to 1982. Bernie served as Legislature Chairman from 1978 to 1980.

Elizabeth Bradley Metcalf, a life long advocate of public education and the mentally Disabled. Mrs. Metcalf served as President of the New York State Association of Mental Health was recognized by the NYS Department of Mental Health and was one of the founders of the Cayuga County Mental Health Center in 1972.

Paul Burke, Member Board of Supervisors and County Legislature 1964 to 1976, Chairman of Board of Supervisors, 1968, and prominent local Civic Leader.

Mary Elizabeth “Betsy” Willis, Assessor of the Town of Sennett, a former long time devoted employee of the Cayuga County Human Services Department, and local Civic Leader

Marco Hecht, formerly of Union Springs, Prominent local Industrialist (Guaranteed Parts Company, General Products Corporation and Ocrum Corporation), civic leader and four time winner of the National Indoor Singles Tennis Competition 1929 to 1932.
