There have been 9,844 cases of COVID-19 in Cayuga County.

Tuesday, November 30th from 4:00-5:00pm at the Fingerlakes Mall

This clinic will offer Pfizer 1st Dose for 5-11 Year-Olds Only

Wednesday, December 1st from 11:00am-2:00pm at the Fingerlakes Mall

This clinic will offer Pfizer 1st & 2nd Doses for 12 and older and Pfizer Boosters for 18+ Year-Olds

Friday, December 3rd from 1:00-3:00pm at the Fingerlakes Mall

This clinic will offer Moderna Boosters and Pfizer Boosters for 18+ Year-Olds Only

REGISTRATION IS REQUIRED – please visit www.cayugacounty.us/health to schedule an appointment. Please bring your insurance card. This clinic will be held at the Fingerlakes Mall located at 1579 Clark St., Auburn at the former Joann Fabric store location. Please enter through the front of the mall to the left of the Bass Pro Shops.

The availability of the vaccine is not limited to just the health department. Individuals are encouraged to work with local pharmacies, federally qualified health centers, and healthcare providers to get an appointment.
