**B.) PROFILE**

**Population**

According to the 2010 U.S. Census, the estimated Town of Ira population was 2,206. The Town of Ira is one of the 23 towns in Cayuga County.

**Location**

The Town of Ira is located in northeastern Cayuga County, sharing its northern and eastern border with Oswego County in the north and northeast, and with Onondaga County in the south. Within Cayuga County, the town is bordered by the towns of Sterling to the northwest, Victory to the west, Conquest to the southwest, and Cato to the south.

**Brief History**

The Town of Ira, along with many other jurisdictions in Cayuga County, was part of the Central New York Military Tract land designated for veterans of the American Revolutionary War. The first settlers arrived around 1800, developing in an area that would first become the Town of Cato. The Town of Ira was officially established in 1821, formed by a split with the Cato. The town’s current borders were drawn in 1824, when Ira ceded a portion of land back to Cato (Storke, 1879).

**Governing Body Format**

Home rule is strong in New York State and thus, each town and village has its own governing body. Towns are made up of a Town Board and Supervisor. Along with town and village roads, any public water and sewer systems are operated by the local municipality, though they may cooperate with County departments. Each municipality has charge over its own planning and zoning and uses the County personnel as a resource (Cayuga County, 2010).

**Growth/Development Trends**

No major residential/commercial development or major infrastructure development are projected at this time for the next five (5) years in the municipality.



### C.) NATURAL HAZARD EVENT HISTORY

Cayuga County has a history of natural hazard events as detailed in Volume I, Section 5 of this plan. A summary of historical events is provided in each of the hazard profiles and includes a chronology of events affecting the County and its municipalities. The classifications listed above relate to the community's effectiveness in providing services that may impact its vulnerability to the natural hazards identified. These classifications can be viewed as a gauge of the community's capabilities in all phases of emergency management (preparedness, response, recovery and mitigation) and are used as an underwriting parameter for determining the costs of various forms of insurance. The CRS class applies to flood insurance while the BCEGS and Public Protection classifications apply to standard property insurance. CRS classifications range on a scale of 1 to 10 with class one (1) being the best possible classification, and class 10 representing no classification benefit. Firewise classifications include a higher classification when the subject property is located beyond 1000 feet of a creditable fire hydrant and is within 5 road miles of a recognized Fire Station.

## F. MITIGATION STRATEGY

### F.1) Past Mitigation Actions/Status

The town has incorporated the following actions into its planning and land use mechanisms:

- The Town has installed a generator. The Cato-Meridian School is located in the Town and available for a shelter.

In the course of their routine administration, the town continues to support the following mitigation actions or programs:

- Participate in local, county and/or state level projects and programs to develop improved structure and facility inventories and hazard datasets to support enhanced risk assessment efforts. Such programs may include developing a detailed inventory of critical facilities based upon FEMA's Comprehensive Data Management System (CDMS) which could be used for various planning and emergency management purposes including:
  - Support the performance of enhanced risk and vulnerability assessments for hazards of concern.

- Support state, county and local planning efforts including mitigation (including updates to the State HMP), comprehensive emergency management, debris management, and land use.

Improved structural and facility inventories could incorporate flood, wind and seismic-specific parameters (e.g. first floor elevations, roof types, structure types based on FEMA-154 “Rapid Visual Screening of Buildings for Potential Seismic Hazards” methodologies). It is recognized that these programs will need to be initiated and supported at the County and/or State level, and will require training, tools and funding provided at the county, state and/or federal level.

**F.2) Hazard Vulnerabilities Identified**

The Town has identified numerous Town roads subject to beaver induced flooding and high organic soils may make some roads prone to subsidence.

It is estimated that in the Town of Ira, 40 residents live within the 1% annual chance flood area (NFIP Special Flood Hazard Area). Of the municipality's total land area, 4.8% is located within the 1% annual chance flood area. \$1,790,115 (1.3%) of the municipality's general building stock replacement cost value (structure and contents) is located within the 1% annual chance flood area. There are 2 NFIP policies in the community and there are 1 policies located within the 1% annual chance flood area. FEMA has identified 0 Repetitive Loss (RL) including 0 Severe Repetitive Loss (SRL) properties in the municipality.

HAZUS-MH estimates that for a 1% annual chance flood, \$113,543 (0.1%) of the municipality's general building stock replacement cost value (structure and contents) will be damaged and 18 tons of debris could be generated. HAZUS-MH estimates no damage or loss of use to critical facilities in the community as a result of a 1% annual chance flood event. In some cases, a facility may be located in the DFIRM flood hazard boundary; however HAZUS did not calculate potential loss. This may be because the depth of flooding does not amount to any damages to the structure according to the depth damage function used in HAZUS for that facility type.

PP= Property Protection: These actions also include public activities to reduce hazard losses or actions that involve (1) modification of existing buildings or structures to protect them from a hazard or (2) removal of the structures from the hazard area. Examples include planning and zoning, floodplain local laws, capital improvement programs, open space preservation, and storm water management regulations.
3. PE=Public Education and Awareness: Actions to inform and educate citizens, elected officials, and property owners about hazards and potential ways to mitigate them. Such actions include outreach projects, real estate disclosure, hazard information centers, and school-age and adult education programs.
4. NR=Natural Resource Protection: Actions that minimize hazard loss and also preserve or restore the functions of natural systems. ### **Explanation of Priorities**

High Priority = A project that meets multiple objectives (i.e., multiple hazards), benefits exceeds cost, has funding secured or is an on-going project and project meets eligibility requirements for the Hazard Mitigation Grant Program (HMGP) or Pre-Disaster Mitigation Grant Program (PDM) programs. High priority projects can be completed in the short term (1 to 5 years).

Medium Priority = A project that meets goals and objectives, benefits exceeds costs, funding has not been secured but project is grant eligible under, HMGP, PDM or other grant programs. Project can be completed in the short term, once funding is completed. Medium priority projects will become high priority projects once funding is secured.

Low Priority = Any project that will mitigate the risk of a hazard, benefits do not exceed the costs or are difficult to quantify, funding has not been secured and project is not eligible for HMGP or PDM grant funding, and time line for completion is considered long term (1 to 10 years). Low priority projects may be eligible other sources of grant funding from other programs. A low priority project could become a high priority project once funding is secured as long as it could be completed in the short term.



**K.) NFIP ADMINISTRATOR INPUT**

**1. Planning and Regulatory**

The Town of Ira joined the NFIP in 2007, and is currently an active member of the NFIP. Current Flood Insurance Rate Maps have been in effect for the community since August 2, 2007. The Town of Ira is proactive in floodplain management with ordinances meeting minimum requirements, including the town's Local Law #1, 1993, Stormwater Management and Erosion Control.

The Town of Ira has no outstanding compliance issues.

**2. Administrative and Technical Staff**

The Town of Ira has identified personnel to manage and uphold the village's compliance with the NFIP. Dedicated staff include: Roger Baldwin, Code Enforcement Officer and NFIP Administrator. This staff member completes numerous tasks in order for the town to be in compliance of NFIP standards. Tasks include permit application review, inspections, stop work orders, and certificates of compliance.

**3. Financial**

As of June 26, 2013 there are two policies enforced within the Town of Ira. Of the two insurance policies, one is within the Special Flood Hazard Area (SFHA), and one is located outside the SFHA. Repetitive loss insurance claims have not been reported within the town. As of June, 2013, there have been zero repetitive loss properties and zero severe repetitive loss properties within the Town of Ira.
