DEPARTMENT UPDATES FOR COMMITTEE:

Steve Lynch (Planning & Economic Development) –

COMMITTEE REPORT

ONGOING DEPARTMENT WORK:

- **NY FORWARD Grant Applications** – Although a number of NY Forward Awards have been announced by the Governor for other upstate NY Economic Development Regions, we are still waiting for Albany to announce the awards for the CNY Region. We are hoping at least one of the individual grant applications planning department staff prepared and submitted on behalf of the Villages of Aurora, Cayuga and Moravia will receive an award. NY Forward is a new state grant program modeled after the NYS Downtown Revitalization Initiative, or DRI, a statewide and competitive grant program. - **Village of Weedsport Zoning Ordinance Update** –Planner Greg Diebold leads this project which is nearing completion. Monthly meetings are the 1st Tuesday of the month. The next meeting is scheduled for Tuesday, February 7th at 6:30 PM. The project is on schedule and progressing well.
- **Town of Throop Zoning Ordinance Update** – Planner Greg Diebold is also the staff assigned to this project. Greg continues to work with the Steering Committee and met with the committee on Monday, January 30 to review the final sections of the Zoning Ordinance. The project is nearing completion and the next meeting is scheduled for Monday, February 27th at 6:00 PM.
- **Town of Conquest Comprehensive Plan** – Senior Planner Greg Hutnik is leading this project. Work with the Town Steering Committee wrapped up on Thursday, January 19th with a final review of the full Draft Comprehensive Plan. Staff circulated the final draft to the Town of Conquest Planning Board for review on Friday, January 27th and will meet with the Planning Board on February 9th (tentative) to review. Following feedback from the Planning Board and any edits to the Plan, staff will circulate the final Draft Comprehensive Plan to the Town Board for review in early March. Processing the final Plan, including SEQRA review and Town Board Public Hearings, etc., will be take place in April with final adoption in May.

- **Village of Aurora Zoning Ordinance Update** – Senior Planner Kari Terwilliger is leading this zoning ordinance update, working closely with the Mayor and Steering Committee appointed by the Village. The January Steering Committee work session was held on January 17th and the February meeting is scheduled for the 14th. The work is on schedule and progressing.
- **Village of Cayuga LWRP & Town of Sterling/Village of Fair Haven LWRP** Final drafts for both Local Waterfront Revitalization Plans remain with the NYS Department of State for a required “consistency review” relative to NYS LWRP policies, with the planning process in on pause until after the state agency completes the reviews.
- **Implementation of the EPA 9-Element Plan for Owasco Lake** – Following completion and approval of the EPA 9E Plan, staff is participating with a range of partners and stakeholders to drive implementation of the Plan’s recommendations. A 9E Plan Coordinating Committee has been established under the Owasco Lake Watershed Management Council and monthly coordinating meetings have been scheduled for the first Thursday of each month following the WQMA standing meetings at the CCSWCD offices.
- **Local Solid Waste Management Plan Update** – The Plan Update is on track and on schedule with new staff Planner Evan Tuthill managing this complex project. An assessment of current programs is complete. Staff is now preparing a range of new solid waste management options and finalizing the draft plans for consideration by all stakeholders. **We will be presenting draft plan provisions to either the full legislature or to the Government Ops Committee in March to solicit feedback on county options for involvement in local solid waste programming going forward so that these may be incorporated into the final countywide solid waste management plan.**
- **Erie Canal Rewatering Project** –Senior Planner Greg Hutnik is leading this project. Engineering and design consultant Bergmann Associates is progressing on design and engineering plans, including a new county bridge at Centerport Road that will accommodate both vehicles and pedestrian pathways while expanding the culvert under the bridge to allow future paddling access beneath the new bridge. A one-year time extension (to December 2023) has been approved by NYS Parks, the grantor. **A Public Information meeting on the project is scheduled for Wednesday, March 8th at 6:00 PM at the Weedsport HS (Cafeteria). The primary meeting goal is to update the public on preliminary plans and seek feedback on design and use options for the trail sections extending from Schasel Park in Port Byron to Aqueduct Park in Brutus.**
- **MICRON Opportunities Working Groups.** The Planning Director continues to work closely with CEDA and the City of Auburn on the MICRON Opportunities Working Group focused on identification of existing shovel-ready sites and the development of new shovel-ready industrial sites for MICRON site selectors seeking development sites for Tier I, II and III supply chain companies. The Working Group has met four times between late December and January and will be meeting again in early February. In addition, the Planning Director is attending the monthly MICRON Opportunities Housing Working Group meetings.

OTHER UPDATES:

Land Use Planning for the Towns of Sennett and Owasco

At the request of the Towns, planning has prepared municipal service proposals for zoning update work with the Towns of Sennett and Owasco.

The Town of Sennett has asked staff to work with the Town on updates to their Zoning Ordinance. The primary focus of the project will be to revise the current Hospitality-Lodging (H-L) Overlay District to better align with the community’s goals and future land use vision for this specific area of the Town. Associate Planner Kari Terwilliger will be leading this project. We will inform the legislature when/if the Town of Sennett decides to move forward.

The Town of Owasco has asked staff for a comprehensive assessment of the current Town Zoning Ordinance and staff has prepared a services proposal for a full update for consideration by the Town. Senior Planner David Nelson will lead this project. We will inform the legislature when/if the Town of Owasco decides to move forward.

As a reminder to committee and other legislators: Under the current professional services policy for assisting Towns and Villages with larger planning projects, the department estimates the full cost of the project, including staff time and reimbursables, and provides the municipality with a 50% discount of the staff labor cost to do the work – essentially providing a 50% grant to the municipality. This structure allows the department to provide comprehensive land use planning services to our Towns and Villages at a fraction of the cost charged by professional land use, planning and engineering firms in the region. Also, the department does not charge for smaller, self-contained planning and community development projects, such as preparing grant applications, short land use studies, planning and zoning board training sessions, etc.

Annual Updates (additions) to the Cayuga County Agricultural District 5. Associate Planner Kari Terwilliger is conducting the annual process allowing landowners to place parcels into Consolidated County Ag District #5. The annual 30-day period for submitting requests for the addition of parcels into the Ag District is from March 1-30, with applications to be made available online.

Kelly King (Employment & Training) –

- Participated in Manufacturing Micro Credential Roundtable at Cayuga Community College- Tour of AMI
- Micron Workforce Development Sub Committee has met twice and is scheduled to meet again on 2/13/2023 at Cayuga Works Career Center.
- Lease negotiations took place between me and CCC and am in the process of starting to draft the sub lease agreements. Workforce Development Building update was provided.
- Open Computer Lab has started to take place on a regular schedule now- 3 times a week for walk ins and one on one appointment options as well. Computer classes are being piloted to DSS groups prior to a public launch in March.
- Two new youth worksites have been developed (1 in Auburn, 1 in Moravia) with one youth placed in each site.
- Youth Program update- 8 youth enrolled in the program with 4 applications pending. 3 enrolled on Paid Work Experience Program and 1 will be starting Certified Nurse Aide training 2/6. 4 receiving case management, leadership, financial literacy, and labor market information.
- Paid out 6 youth incentives this month for completion of Job Zone portfolio. \$100.00 for each incentive.
- Currently have one On the Job Training contract with a local employer and setting up a contract with another.
- Attended training on New York State DOL changes to program eligibility for WIOA Adult training program.
- Classroom Training update- 8 participants enrolled in LPN training at Cayuga Onondaga BOCES and 2 enrolled in RN program at Pomeroy College of Nursing/Crouse Hospital. 2 students successfully completed CASAC T program at Cayuga Community College and are both now employed as Peer Advocates while working on obtaining the full CASAC credential to become a counselor.
- Front door traffic this month-240 people
- DSS/JOBS contract update- 83 active TANF applicants; 72 active Safety Nets; 30 Non-Employable participants served; 65 total served.
- Marketing and recruitment/business contacts- new job orders/Facebook posts- Cayuga County, WIC, Access to Homecare, American Cierra Plastics, Mozaic, Internal Medicine Associates of Auburn, Fastrac, New Beginnings, Emcom, and NYS OCFS/Harriet Tubman, Northbrook Heights, Northwoods and more.

Michael Miller (CEDA) –

Metric Snapshot as of January 2023 :

- Existing businesses assisted: 18
- Entrepreneurs assisted: 13

- CEDA held an additional meeting of city, county stakeholders concerning whole-sale water rates at their offices. Continuing discussions to be held throughout 2023 for development of an equitable whole sale water- rates.
- Maureen Riester met with Cayuga County Town Supervisors to discuss CEDA's services to the community; CEDA will look to continue engaging with town/village officials throughout 2023
- CEDA hosted a discussion with local business leaders on the feasibility and support of a business accelerator for Cayuga County. Michael Miller and Maureen Riester will be touring potential sites for the accelerator and meeting with representatives from the Tech Garden in Syracuse to learn of best practices. While further due diligence is completed, current outlook is optimistic
- CEDA continues to participate and partner with representatives from the county, city of Auburn, and private business owners on opportunities related to Micron.
 - CEDA staff met with Steve Lynch and others in evaluating potential sites for acquisition and development; will continue to meet as a team through acquisition and development
- Michael Miller met with Megan Florkowski, the Director for WISE (Woman Igniting the Spirit of Entrepreneurship) to discuss areas of collaboration. WISE, while located in Syracuse, offers programs both in-person and virtually for residents in Cayuga County at little to no cost. Programs are specific to woman and offer professional consultative mentorship. CEDA is looking to partner with WISE, as is done with the SBDC, on providing assistance and guidance to our area's entrepreneurs and small businesses.
- CCIDA has a strong pipeline of activity anticipated for 2023 which includes CMI's expansion project in the Industrial Park, numerous inquiries by power projects, and efforts to secure new sites for new IDA site development.
- Michael Miller and Maureen Riester will be attending the EDC Annual Conference in Albany on March 1st. The event provides a key networking opportunity and development of emerging best practices for economic development initiatives (this includes site selection, housing stock, community positioning, and economic impact assessments).

Doug Kierst (Soil & Water Conservation District) –

- Policy Matters for Committee

AGRICULTURAL TECHNICAL ASSISTANCE:

- Cayuga SWCD Staff continue to process Soil Group Worksheets for Agricultural Assessments, in preparation for the Town Assessors March 1, 2023 deadline. Agricultural properties in all the Towns, and even the City of Auburn, are required to have a current soil group worksheet to qualify for an agricultural exemption.

- Cayuga SWCD Staff are working with farms on project planning for Best Management Practice (BMP) implementation projects funded through the Agricultural Nonpoint Source Abatement and Control Program and the Climate Resilient Farming Grant Program. The grant programs are expected to announce that they are open to receive applications soon.
- Cayuga SWCD Staff continues to complete grant closeout paperwork for projects that have been completed utilizing funding through various NYS grant programs. Four grants are scheduled to be closed out the NYS Dept of Ag and Markets in the coming months.
- Cayuga SWCD Staff have been working with landowners, as the crops were being harvested, to implement soil health improving and erosion prevention measures on farm fields. Since my last report, Cayuga SWCD Staff can report assisting with the implementation of an additional 3,370 acres of cover crops and 824 acres of reduced tillage management that have been applied on agricultural land in Cayuga County.
- Cayuga SWCD Staff continue to complete monthly construction site inspections on one SPDES permitted construction site at an agricultural operation in the Cayuga Lake Watershed.
- Cayuga SWCD Staff continue to participate in meetings involving the review of the Draft revision of the Owasco Lake Watershed Rules and Regulations.
- Cayuga SWCD Staff continue to assist with the review and updating of the model used in the 9E plan for Owasco Lake.

NON-AGRICULTURAL & MUNICIPAL TECHNICAL ASSISTANCE:

- Cayuga SWCD Staff completed site visits on several properties to assess drainage and flooding concerns that resulted from the wet weather.
- Cayuga SWCD Staff continue to complete weekly construction site inspections on one SPDES permitted construction site in the Owasco Lake Watershed and one in the Seneca River Watershed.
- Cayuga SWCD Staff have met with Alpha Boats Unlimited to review the status of the new Aquatic Vegetation Control Program harvester, shore conveyor and trailer. The equipment is being built and is currently on schedule to be completed in time for the 2023 harvest season.

OTHER SWCD NEWS, WORKSHOPS & TRAININGS:

- The Cayuga SWCD worked with the Cayuga Recycles Program (through the Cayuga County Planning Department) and Cornell Cooperative Extension of Cayuga County to sponsor the Annual “Trade-A-Tree” program in Cayuga County. Approximately 100 County residents recycled their real Christmas tree after the holidays.
- Cayuga SWCD Staff taught one NYS DEC endorsed 4-hour training for contractors, municipal officials, engineers and other groups interested in learning about erosion and sediment control methods. We have additional workshops scheduled for February 21st, March 21st, April 18th and May 16th.
- The Cayuga SWCD is holding our 52nd Annual Spring Tree Seedling and Groundcover Sale. As in the past, the District is offering a variety of New York grown conifers, hardwoods, shrubs, and groundcovers. These seedlings, transplants and other plants are a very low-cost way to prevent erosion, improve water quality in our lakes and streams, to promote wildlife in your area, as well as create noise and visual buffers, and both snow and wind breaks. The Cayuga SWCD will be taking orders through Tuesday, May 2nd, 2023. The pickup date will be Friday, May 12th, 2023. Supplies are limited, so order early for the best selection.
- The Cayuga SWCD, in partnership with the Tompkins County SWCD and Cornell Cooperative Extension hosted a Winter Crop Meeting on Thursday, January 26th, 2023 at the Auburn Holiday Inn. Topics included an Overview of a No-Till Cropping System, Soil Compaction, Impacts of Neonics and Nematodes on Corn Insect Management, Corn Diseases – Identification and Options for Management and Biochar for NYS Ag: an Intro and Application to Soils. The meeting was co-sponsored and supported by the Cayuga and Tompkins SWCDs through grant funding obtained through the Ag Nonpoint Source Abatement and Control Grant Program, Round 26. Approximately 57 farmers attended the event.

Dan Welch (Director Cornell Cooperative Extension) –

- o On February 10th, 4-H youth will be participating in county public presentations, and on the 13th is county horse communications. 4-H Public Presentations is a program in which youth learn to create a presentation and develop the skills needed to present it before an audience. They learn about the research process and the steps needed to organize information into an interesting and creative presentation.
- o CCE Cayuga and Cayuga SWCD held a Winter Crop Meeting in Auburn on January 26th. 50 Farmers and agri-business professionals learned more about managing a no-till cropping system, reducing impacts soil compaction, plant disease management, and recent developments in biochar.

CCE Cayuga is working with the Community Action Program to provide nutrition education for parents

WHEREAS, the water quality of Cayuga Lake is important to Cayuga County and its residents; and

WHEREAS, the Cayuga Lake Watershed Restoration and Protection Plan 2017 recommends consistent monitoring of the lake and its tributaries as necessary for the restoration and protection of the Cayuga Lake Watershed; and

WHEREAS, Grascen Shidemantle, Executive Director of the Community Science Institute (“CSI”), has proposed a 2023 Cayuga Lake Harmful Algal Bloom (“HABs”) Monitoring Program (the Project) that would be funded by the Counties bordering Cayuga Lake; and

WHEREAS, the Total Project Cost to the County is a not-to-exceed fee of \$8,000.00, with Planning & Economic Development Department’s WQMA budget providing \$8,000.00 from FY 2023 budget item A87404-54059, which is specifically allocated for professional services and targeted research related to the Cayuga Lake HABs Monitoring Program; and

WHEREAS, Cayuga County deems it to be in the public interest and benefit to enter into an agreement to conduct this HABs monitoring of Cayuga Lake; and

WHEREAS, the CSI professional services proposal is considered a sole source procurement agreement for professional services in the context of the ongoing research, monitoring and data collection on HABs conducted by CSI in Cayuga Lake over a number of years;

NOW, THEREFORE BE IT RESOLVED, by the Cayuga County Legislature as follows:

1. The Chair of the Legislature is hereby authorized and directed to sign such documents with the Community Science Institute of Ithaca, New York, for a 12-month professional services term starting March 1, 2023 and ending on February 28, 2024, as may be necessary to implement this Project so long as contract costs do not exceed the proposed Project cost of \$8,000.00, upon review and approval as to form by the County Attorney’s Office; and

WHEREAS, Grascen Shidemantle, Executive Director of the Community Science Institute (“CSI”), has proposed a sampling program for tributaries of Cayuga Lake in Cayuga County for 2023 (the Project); and

WHEREAS, the Total Project Cost to the County is a not-to-exceed fee of \$22,000.00, with Planning & Economic Development Department’s WQMA budget providing \$22,000.00 from FY 2023 budget item A87404-54059, which is specifically allocated for professional services and targeted research related to Cayuga Lake stream monitoring; and

WHEREAS, Cayuga County deems it to be in the public interest and benefit to enter into an agreement to conduct this stream monitoring on Cayuga Lake; and

WHEREAS, the CSI professional services proposal is considered a sole source procurement agreement for professional services in the context of the ongoing research and data collection conducted by CSI in Cayuga Lake and its major stream tributaries over a number of years;

NOW, THEREFORE BE IT RESOLVED, by the Cayuga County Legislature as follows:

1. The Chair of the Legislature is hereby authorized and directed to sign such documents with the Community Science Institute of Ithaca, New York, for a 12-month professional services term starting March 1, 2023 and ending on February 28, 2024, as may be necessary to implement this Project so long as contract costs do not exceed the proposed Project cost of \$22,000.00, upon review and approval as to form by the County Attorney’s Office; and

AUTHORIZING A CONTRACT EXECUTION WITH THE OSWEGO COUNTY SOIL AND WATER CONSERVATION DISTRICT FOR THE TRANSFER OF NYSDEC FUNDING FOR THE FINGER LAKES-LAKE ONTARIO WATERSHED PROTECTION ALLIANCE TO CAYUGA COUNTY, STATE FISCAL YEARS 2022 – 2023 FUNDING

WHEREAS, Cayuga County, as one of the twenty-five (25) voting members of the Water Resources Board of the Finger Lakes-Lake Ontario Watershed Protection Alliance (FLOWPA), has been allocated NYS Department of Environmental Conservation (NYSDEC) funds for its water quality program under the FLOWPA; and

WHEREAS, NYSDEC has agreed to transfer funding for the twenty-five (25) member programs to the Oswego County Soil and Water Conservation District (DISTRICT) via a single contract between NYSDEC and the DISTRICT; and

WHEREAS, the County of Cayuga is eligible to receive \$97,200.00 in State Fiscal Year (SFY) 2022-2023 FLOWPA funding, which will be used to enhance, protect and preserve Cayuga County's water resources; and

WHEREAS, the Cayuga County Legislature wishes to execute the contracts necessary for the County to access and allocate these state funds for the preservation and protection of Cayuga County's water resources; now, therefore be it

RESOLVED, that the Chair of the Cayuga County Legislature is hereby authorized and directed to execute a contract between Cayuga County and the Oswego County Soil and Water Conservation District for the FLOWPA funding as specified in said contract, upon review and approval as to form by the Cayuga County Attorney's Office; and to act as the official representative of Cayuga County in connection with any and all contracts between Cayuga County and the Oswego County Soil and Water Conservation District for FLOWPA funds; and be it further

RESOLVED, that a signed, certified copy of this resolution be submitted to the District Manager of the DISTRICT along with said contracts; and be it further

RESOLVED, that the Planning and Economic Development Department's 2023 budget currently includes the \$91,200.00 in the Department's A87410 43994 A State Aid – FL/FLOWPA GRANT revenue account and \$6,000.00 in A80200 42115 Lake Management revenue account and \$97,200.00 in A87414 54000 -A FLOWPA GRANT expenses account; and be it further
