Authorizing the Cayuga County Legislature to Create and the Public Health Director to fill seven (7) Registered Professional Nurse positions in the Public Health Department.

WHEREAS, there is a need for nursing staff during the current COVID-19 pandemic; and

WHEREAS, funding has been made available to the Cayuga County Health Department to provide services to the people of Cayuga County during the COVID-19 pandemic; and

WHEREAS, a New Position Duties Statement submitted to the Cayuga County Civil Service Commission was reviewed, and the Commission determined that the job responsibilities are in line with the job duties of a Registered Professional Nurse in the Competitive Class, and classified it as such; and

WHEREAS, funding for the newly created positions exists in the A40254-54000 line of the Cayuga County Public Health Department budget as part of the Public Health Preparedness funding Grant, now therefore be it

RESOLVED, that the Cayuga County Legislature creates 7 Registered Professional Nurse positions in the Cayuga County Public Health Department; and be it further

RESOLVED, that the Public Health Director be authorized to fill the 7 newly created Registered Professional Nurse positions on a part time basis, and be it further

RESOLVED, that the hourly rate for the Registered Professional Nurse position be set at \$26.13, as indicated in Part II of the Cayuga County NB compensation plan, and be it further

RESOLVED, that the Registered Professional Nurse positions be abolished when they are vacant due to the exhaustion of funds.
