CCOFA has been offered additional office space at the Boyle Apartment building due to the closure of RSVP. This represents an opportunity to have all CCOFA staff together which has and continues to be the goal. Following a tour, I am waiting on clarification from Christopher Community as to whether the space could meet the need for 5 HIPPA complaint spaces, and accommodate all 7 CCOFA staff currently at COB. Once this information is received, I expect to be able to share cost estimates and bring the details to the HHS committee for further discussion.

- Eviction Moratorium extended to May 1
- FFFS/Code Blue/STSJP plans all approved by OCFS/OTDA
- SAMHSA released another round of System of Care grants and we're applying again
- We received another round of funding (70k) for the CPS embedded behavioral health specialist
- The Medicaid weekly share payment beginning 3<sup>rd</sup> week in January will be reduced by approximately \$30k. You may remember this payment was reduced last year and this is an additional reduction
- We are keeping up on the vaccine rollout. OMH/OASAS pushing information out on priority populations but no information yet from OTDA/OCFS
- We continue to push out funding via the HEALing Communities study
- No word yet on the status of CY OMH/OASAS local and regional State Aid
- Assertive Community Treatment Team to start 1/1/21. We've made several referrals
- DePaul continue to work on the Port Byron housing project and is applying again. The project renovates the old high school, creating affordable housing opportunities for folks with MH/SA disabilities and frail elderly and also creates satellite service opportunities for the underserved north end of the county
- We've managed to keep homeless numbers around 50 households. There's been a shift to an increase in families experiencing homelessness

WHEREAS, Cayuga County Department of Social Services must provide for supervised visitation services for families who have children in Foster Care; and

WHEREAS, we have seen an increase in young children coming into Foster Care and an increase in the number of court-ordered supervised visits being ordered; and

WHEREAS, the Department desires to contract with Catholic Charities of the Finger Lakes to provide observation of parent and child interactions for scheduled supervised visits as assigned by the Department; and

WHEREAS, Catholic Charities would work cooperatively with the Department to arrange a schedule that is appropriate to the needs of the child, the parent, and other key participants that accommodate the transportation needs of parties involved; and

WHEREAS, as a result of this service, Catholic Charities would provide the Department with a comprehensive, written report detailing observations including the arrival time of participants, the condition of the visitation site, the extent to which the parents interacted and engaged the child, the appropriateness of interaction between the participants and other general observations; NOW, THEREFORE, BE IT

RESOLVED, that the Chairman of the Legislature and the Director of Community Services enter into a contract with Catholic Charities of the Finger Lakes for the period January 1, 2021 to December 31, 2021, for the provision of supervised visitation services at the following rates:

Standard Unit of Service (60 min.).....\$43.00

WHEREAS, the Department of Social Services is responsible for providing preventive services to forestall foster care placement and the Department of Mental Health is responsible for providing services that support children and families; and

WHEREAS, the Family First legislation requires substantial efforts to keep children at home or with relatives, a reduction of congregate care placements and shortened foster care stays; and

WHEREAS, Cayuga Centers provides the following services that meets those needs:

- Family Preservation Program: Rate @\$74.68
- Family Support Program: Rate @\$74.68
- Enhanced Foster Parent Support Program: Rate @\$530.15
- Safe Care: Rate 1/12

and

WHEREAS, such services are reimbursed by the State at 62% net of Federal (preventive funding), by 100% MH State Aid and now by Medicaid and Cayuga County has worked to blend funding streams to create a more sustainable funding model and created and implemented a robust contract oversight/monitoring process with the Families Accessing Services Team (FAST); and

WHEREAS, the combined budget for these programs is \$572,772 with a county share of \$385,220 (blend of \$322,220 and \$63,000 MH State Aid) with Cayuga Centers assuming the risk for the balance of \$187,552 and Cayuga Centers agrees to hold Cayuga County harmless should the Medicaid target not be met; and

WHEREAS, the Department of Social Services desires to contract with Cayuga Centers to provide these services that are budgeted in the 2021 departments' budget; NOW, THEREFORE, BE IT

RESOLVED, that the Chair of the Legislature and the Director of Community Services are hereby authorized to enter into a contract with Cayuga Centers to provide these services for the contract period of January 1, 2021, through December 31, 2021 at a total county cost of \$385,220.00 with Cayuga Centers agreeing to hold Cayuga County harmless for the balance of projected Medicaid revenue of \$187,552 and upon such form as may be approved by the County Attorney.
