LEG Set Salary Treas

Setting the salary for the Office of the Cayuga County Treasurer for the term beginning January 1, 2022

BY: Hon. Aileen McNabb-Coleman, Chair, Cayuga County Legislature

WHEREAS, the term of office for the Cayuga County Treasurer is expiring at the end of the current year with election for office taking place in November; and

WHEREAS, recent changes in N.Y. Election Law has created earlier deadlines for individuals who wish be a candidate for elected office; and

WHEREAS, the Cayuga County Legislature is charged with the responsibility of setting the salary for the Office of the Treasurer; finds that setting this salary prior to the deadline for becoming a candidate for said office is in the best interests of the residents of the county and potential candidates themselves; and believes that doing so fosters equity and neutrality in compensation of future office holders;

WHEREAS, a Finance Committee has been set to plan and prepare for the establishment of a Finance Department and the establishment of a Director of Finance in order to further professionalize the finances of Cayuga County and provide consistency across all financial aspects of County government;

WHEREAS, the addition of a Finance Director to oversee the Finance Department will the result in a decreased workload of the County Treasurer, therefore the salary will be reduced by half, and the Office of treasurer continues to be eligible for Health Insurance, therefore be it

RESOLVED, that the salary for the Cayuga County Treasurer be as follows:
