- 34 unvaccinated, 32 vaccinated

Confirmed Cases – total since March 18, 2020:

There have been 10,203 cases of COVID-19 in Cayuga County.

Friday, December 10th from 1p-3p in the Events Center at the Fingerlakes Mall (former Spirit Halloween store). This clinic will offer J&J Booster shots, J&J original dose and the Moderna Booster.

Please enter through the back of the mall. You will not be able to enter through the inside of the mall.

REGISTRATION IS REQUIRED – please visit www.cayugacounty.us/health to schedule an appointment. Please bring your insurance card.

The availability of the vaccine is not limited to just the health department. Individuals are encouraged to work with local pharmacies, federally qualified health centers, and healthcare providers to get an appointment.
