Revised Set Back Law

A revised set back law is now in effect. A copy can be obtained from the Locke Town Clerk during her office hours.

Do you have a dog? A reminder to all Locke residents that have dogs harbored within the town. It is required by law to license any dog over the age of four months. A valid rabies certificate is needed to license your dog and cost is \$13.00 for unsprayed/unneutered dogs and \$5.00 for spayed/neutered dogs. Proof of spay/neuter is also required at the time of licensing. Renewal notices are also sent out as the dog licenses are valid for one year only. Renewals are expected to be done in timely manner.
